The Board of Directors of Piteå Hamn AB (corporate identity number 556643-1911) has adopted the following price list to be covered and apply from 1 January 2026.

The price list applies within the area of operation of Piteå Hamn AB and the railway infrastructure managed by the Municipality of Piteå.

The invoiced amount must reach the Port of Piteå no later than 30 days after the invoice date. Penalty interest is charged under the Interest Act.

A. SERVICES FOR VESSELS CALLING

1. SHIP-GENERATED SCRUBBER WASTE

A charge for reception of waste from ships will be made in accordance with Swedish legislation and Swedish Transport Agency regulations (TSFS 2023:15).

Scrubber waste For scrubber waste left in the Port of Piteå the actual cost to the contracted waste recipient will be charged plus an administration fee of SEK 750.

2. FRESHWATER

In the case of water supply outside normal hours of work, an additional hourly charge for personnel will be made in accordance with D.5. In the case of abnormal interruptions to water supply to the port, a charge will be made for the actual additional costs.

3. ELECTRIC POWER

Energy consumption will be charged at actual cost plus a 10% surcharge.
There is an additional hourly charge for connection of electric power in accordance with D.5.

4. SERVICE BOATS

Service boats must always be operated by two persons from the port personnel. A charge for personnel costs will be made in addition to the service boat fee, in accordance with D.5.

5. ENERGY TERMINAL SERVICES AND OTHER SERVICES

Energy terminal personnel work 12-hour shifts (start of shift 7.00 am and 7.00 pm). A deferred start of shift must be approved by the port.

6. TUG ASSISTANCE

Restrictions for tug assistance at the Port of Piteå can be found on the National Maritime Administration website:

Tug assistance is offered during the ice season (1/1 to 15/4). During that period there is a tug at the quay for ice-breaking of the port's fairway. A charge will be made for towing in the fairway up to the quay and for berth shifting at the quay according to a price list. During other times of the year the supplier of tug assistance should be contacted directly.

The fees relate to two persons. A charge will be made for further personnel in accordance with D.5.

Berth shifting along a quay is charged in accordance with Boatmen and Mooring Services above. D.7

7.2 Ordering of boatmen

Monday–Friday 7.30 am to 4.00 pm: the port office, telephone 0911-23 21 30.

Other times: Securitas, telephone +46(0)70- 191 87 00.

Boatmen should be ordered in the agent portal, Port.

If the ship arrives or departs more than 30 minutes after the ordered time, a fee is charged for waiting time in accordance with D.5.

A boatman obligation applies to all vessels. In exceptional cases, exemptions may be granted by the port management.

If a mooring boat is required or ordered, a fee is charged in accordance with D.4 and D.5.

E. RAILWAY TRACK FEES

8. TRACK FEE

8.1. Track fee

A track fee will be charged for traffic on the railway infrastructure managed by the Municipality of Piteå. Information on applicable track fees can be found in the document Description of Railway Network.

8.2 Emission line fee

Emission fee for locomotives and railcars operated with liquid or gaseous fuels arriving at or departing from the port by rail.

SEK 57 per locomotive/railcar

8.3 Siding fee

A siding fee for units parked on all managed tracks will be charged after three days counting from date of arrival.

SEK 57/day and car

F. STORAGE OF GOODS

9. RENTAL PROVISIONS

9.1 General rental provisions

Rent is charged for temporary storage, putting into store and parking of goods in accordance with F.9.2

Seven days of free storage will generally be given for arriving and departing goods handled in a designated space within the logistics area. One day is counted from midnight to midnight. Started months and parts of months will be charged as whole months.

For goods that over time occupy a fixed area, rent will be charged in accordance with F 9.2. Covered space will be provided subject to availability.

Reserved storage areas at the start of the period, including additional areas such as protection zones, driving routes and barrier equipment, forms the basis of charging.

Pads, reinforcements, support plates or similar are required for goods that impose a load of more than 10 tonnes/m² (100 kN/m²) on the ground. A separate charge will be made for this.

The tenant of the storage area must bear the cost of and provide the following:

- Cleaning and tidying during and before the due date of the rental period.
- Necessary winter road maintenance for unloading, loading, storage, etc.
- Normal operational measures for the tenant's cargo handling (sweeping, dust control, etc.)
- Insuring of stored goods

Piteå Hamn AB cannot be held liable for damage, loss, etc. of stored goods.

100% on the storage price after 6 months.
